

Fish-Rite Aluminum Boats Warranty

All customer warranty registration cards are the responsibility of the dealer. Registration cards must be submitted / received within **15 days** of the purchase date. Please be aware that any / all warranty work required will not be approved if the registration card is not found on file at the factory.

WARRANTY COVERAGE

- 1 Year on all misc. electrical and rigging parts.
- Lifetime (to original purchaser) on any major structural defects, main seam weld which includes hull side, bottom, transom chine & center keel. (Lifetime refers to a period not to exceed 20 years).

Motors:

- Refer to Manufacturer's Warranty
- Commercial use 90 days.

Inboard Pumps:

- Refer to Manufacturer's Warranty
- Commercial use 90 days.

All warranty work must have prior approval from the factory via a warranty application form processed by emailing warranty@blueearthmarine.com. Warranty claims must be submitted within **30 days** of completion of work performed. If the factory deems fit to repair any warranty claim, it will be the responsibility of the owner of the product to ship the boat to and from the factory.

DEALER RESPONSABILITY

Dealer must submit any defects noticed by shipping within 7 working days of receiving product. After which time it will be the sole discretion of Fish-Rite boats whether to warrant claims received.

ITEMS NOT COVERED BY LIMITED WARRANTY

Corrosion or damage caused by -

- Electrolysis
- Fuel spills or over filling
- Use of harmful cleaners or solvents
- Improper use of antifouling paint
- Dissimilar metals
- Salt water as a result of zinc anode absence, cathodic protection device and or improper storage / moorage / neglect, maintenance or cleaning. All parts not manufactured by Fish-Rite boats must be processed / warranted by the respective manufacturer
- Canvas (tops are not towable up)

Damages caused by -

- Freezing water or operating in subzero temperatures
- Loading, storage & trailer hauling
- Accidents, theft or misuse

Damage resulting from unauthorized alterations or modifications to the boat or work that has done by a been third party. Leaking around windshields, latches and other openings.

PROCEDURES FOR WARRANTY REPAIR

All warranty claims must go through a Fish-Rite Dealer

IMPLIED WARRANTIES AND EXCLUSIONS

Except or otherwise stated herein, Fish-Rite disclaims liability for any express or implied warranties, including any merchantability or fitness for a particular purpose. Fish-Rite disclaims liability for indirect, incidental or consequential damages, which disclaimer applies during and after the warranty period. This warranty is limited to an amount not exceeding the cost of correcting the defects as herein provided and shall not exceed the original purchase price paid for the product manufactured by Fish-Rite. At the expiration of the warranty period all such liability shall terminate. Warranty does not extend to engines or components installation which requires additional make ready servicing, adjustment or final assembly in preparation by the dealer for delivery to the original purchaser, any defect due to the negligence of others; failure to operate or maintain the product in accordance with acceptable practices; unreasonable use; damage, accidents, abuse, damage resulting from impact, negligence, alterations, third party installations, ordinary wear and tear; use of the product for racing purposes; use of performance products (other than those recommended by the factory) that place undue stress on parts such as (jack plates) and modifications of any sort; exceeding horsepower rating and load capacities labels, failure to trim boat properly while running, trailering damage, towing behind another boat and other cases of misuse without limit. Warranty only applies to original purchaser.
